## Programme Structure

### Admission & Performance Requirements

All applicants shall be enrolled in the PG certificate level initially based on the following requirements:

- a) Hold a degree in any discipline and have at least three years of supervisory/managerial experience.
- b) Interviewed by the MBA selection Committee prior to admission to ascertain the suitability of the candidate for the programme.
- c) Students under "Mature Entry" category shall be considered case-by-case basis. Applicants in this category generally need to have a diploma level qualification and 5-years of managerial experience.
- d) Students who fail to meet the above admission requirement (a) may be required to undertake a bridging course (MGT302) and achieve a grade of B or above.
- e) On completion of the first three units candidates must achieve a GPA of 2.5 or better to proceed to PG Diploma level. Those who wish to continue to the MBA degree must obtain a GPA of 3.0 at PG Diploma level.
- f) A candidate who fails a course at more than two attempts, or fails to pass two different courses will not be allowed to continue.
