Qualifications

- 1. A student is eligible to apply for a scholarship/loan if he/she:
 - Is a Fiji citizen permanently residing in Fiji.
 - Is given full admission into a degree, diploma or certificate programme at the University.
 - Is fully supported by parents/guardians whose combined gross annual income does not exceed \$10,000.
 - Meets any other condition(s) imposed by the University.
- 2. Those currently serving or are required to serve a bond for any other scholarship or loan are ineligible.
- 3. Provision, declaration, certification or endorsement of false information will disqualify the applicant from this scholarship award; it may also lead to legal action being taken against the offender(s).
- 4. The University Scholarship/Loan Committee's decision is final.

Any other guardian must sign a Statutory Declaration before a Justice of Peace or Commissioner of Oaths before making the declaration in Section D regarding their guardianship status.
